**PET CARE AND PAYMENT**

- 1. Pet care services will be provided at current rate as published on the website, [www.kristypetsitting.com](http://www.kristypetsitting.com), subject to change with written notice. Written notice includes publication of updated rates on [www.kristypetsitting.com](http://www.kristypetsitting.com). Client affirms that they are aware of pricing policy as indicated on website and that services are provided at rates posted on the website at time of service, unless otherwise agreed to in writing. \_\_\_\_\_ Initial
- 2. Client authorizes Provider to perform pet care services as outlined in Owner Information, Pet Information, Medication Information and Veterinary Information and Release, which shall become part of this contract. Information provided in the aforementioned forms must be kept current, prior to any future pet care services Client agrees to notify Provider of any changes to the information on these forms in writing. \_\_\_\_\_ Initial
- 3. Emergency care: In the event that pet(s) being cared for require immediate medical attention, Provider will attempt to contact the Client prior to obtaining emergency care. However, Client agrees that Provider has the authority to act in pet’s best interest even if this means seeking medical attention prior to notifying Client. Client agrees to reimburse Provider for any additional fees and/or expenses incurred while tending to emergency or veterinary care. \_\_\_\_\_ Initial
- 4. Inclement weather/Natural disaster/Act of war: In the event of inclement weather, natural disaster, or act of war Provider is entrusted to use best judgment in caring for pet(s). Client recognizes that in the event of inclement weather, natural disaster, or act of war Provider reserves the right to alter services outlined in this contract. \_\_\_\_\_ Initial
- 5. Personal emergency: In the event of personal emergency or illness of pet sitter, Client authorizes Provider to arrange for another qualified person to fulfill agreed upon responsibilities as set forth on this contract. Client will be notified in such case. \_\_\_\_\_ Initial
- 6. Payment: Client agrees to make payment in full prior to, or at the time of, the first visit. If a check is returned for non-sufficient funds, Client will be charged an additional \$30.00. \_\_\_\_\_ Initial

7. The Client is responsible for paying all attorney fees and expenses, court costs, and any other costs incurred by the provider to collect any overdue balances and interest. \_\_\_\_\_ Initial
8. Extra Services: Any charges for unplanned services will be due within 7 days of completion of service engagement. \_\_\_\_\_ Initial
9. Deposits: A 50% deposit is required at booking prior to the start of service for all overnight stays and any service package totaling \$200 or more. \_\_\_\_\_ Initial
10. Cancellation: If you have to cancel any of your scheduled services please refer to the cancellation policy below to see what your charges will be. \_\_\_\_\_ Initial
- **Less than 1 week notice prior to any service:**  
Deposit is non-refundable.
  - **1-2 week notice prior to any service:** 50% of your deposit will be refunded.
  - **More than 2 week notice prior to any service:** Deposit will be reimbursed in full
11. Late Pickup: If Client fails to pick pet up within 4 hours of agreed upon time, Provider will contact Client, the Emergency Contacts as designated on the Emergency Information Form provided by Client, and the Veterinarian as indicated on the Veterinarian Information and Release Form. If Client still fails to inform Provider of the reason for the delay and provide authorization to extend contract term and pay all applicable charges, Provider will contact local Animal Control to pick up the pet. \_\_\_\_\_ Initial

## LIABILITY

1. Provider, its employees and/or independent contractors, agrees to provide the services in a caring, responsible manner. The client waives and relinquishes any and all claims against Provider, its employees and/or independent contractors, except those arising from negligence of the pet sitter. \_\_\_\_\_ Initial
2. Emergency contact: Client agrees to provide Provider with contact information where he/she can be reached while away. Client will also provide a name and phone number of someone who is authorized to handle any major problems that may arise. If Client or designated contact person cannot be reached in a timely manner, Client agrees to accept any decision Provider makes in regards to pet care or Client's property. \_\_\_\_\_ Initial
3. Aggressive pets: If a pet has a history of biting or other aggressive behavior, Provider reserves the right to refuse or cancel service. The owner will be liable \_\_\_\_\_ Initial

for the pet sitter's medical expenses and/or damages that are the result of an animal bite or injury due to pet's aggressive behavior.

- 4. Destructive pets: If a pet has a shown destructive behavior, Provider reserves the right to refuse or cancel service. The owner will be liable for replacing the pet sitter's property that the pet destroyed due to a pet's aggressive behavior. \_\_\_\_\_ Initial
- 5. Vaccinations: Client agrees to provide Provider with proof of current vaccinations for all pets. Should pet sitter be bitten or otherwise exposed to any disease or ailment received from Client animal(s), Client agrees to pay all costs and damages incurred. \_\_\_\_\_ Initial
- 6. Future Services: Client authorizes this signed contract to be valid for future services without additional signed contracts or written authorization. \_\_\_\_\_ Initial

**ADDITIONAL**

- 1. The Client agrees to allow Provider the right to advertise and create other promotional materials using pictures taken by the Provider at the Provider's place of business. \_\_\_\_\_ Initial
- 2. If any term or provision of this agreement is deemed to be invalid or unenforceable, such a determination will not affect any of the remaining terms and provisions. All such remaining terms and provisions will remain in full force and effect. \_\_\_\_\_ Initial
- 3. Modifications: Any oral changes made to this agreement regarding the terms of service shall be enforceable to the full extent of the contract. \_\_\_\_\_ Initial
- 4. All terms hereunder will be interpreted as to the laws of the State of Maryland. \_\_\_\_\_ Initial
